| <b>Contract Term/Length</b>  | <b>12 months fixed rate</b> - initial term after the EDC processes enrollment.   |
| <b>Renewal Terms</b>   | This Agreement does not renew automatically. At the end of the contract term, if you do not choose a new product, your account will move to a month-to-month variable product. Prior to the expiration of your contract term, you will receive two renewal reminders; one at 60 days and one at 45 days, which will outline your options for renewal.  |
